LIMITED LIABILITY COMPANY AND OTHERS

1. Duly filled and signed application form
2. A stamped copy of the certificate of incorporation (*Certified by Commissioners of Oaths*)
3. Original stamped or company sealed Board Resolution on company letter head signed by at least two directors within 30 days stating:
 - a. Authority to open an account or transact business on behalf of the company
 - b. Appointed persons having signatory authority and provide copies of their identification documents (*Certified by Commissioners of Oaths*)
 - c. Bank details
4. KRA PIN certificate for the company and directors (*Certified by Commissioners of Oaths*)
5. Copy of CR12 (*With a validity of 90 days*)
6. Copy of utility bill
7. Copy of identification documents of persons opening the account i.e. National ID/Military Service Number, Passport/Alien ID (*Certified by Commissioners of Oaths*)
8. Copy of business trading license
9. Cancelled cheque or letter from your Bank confirming bank details
